- Two open positions at LRE – Quality Assistant and Data Analyst
- Lawsuit filed by Muskegon County against LRE has been dismissed
- LRE is seeking authorization to provide Opioid Health Home and Behavioral Health Home services in the region. Barriers in implementation of these programs are related to the decentralization of SUD services in Region 3.
- Region is working to add Habilitation Support Waiver (HSW) slots. Thus far, we have been offered 30 slots from Midstate Health Network PIHP. This will need to be approved by the state.
- Financial audits for FY18 – FY22 have been revised and submitted. FY2023 audit is underway
- Working to update the PIHP/CMHSP subcontract.
